In February, NESSI continued discussing NESSI's position for the re-organisation of ETPs within the context of the upcoming launch of Horizon 2020. In parallel, NESSI started preparing for the <u>Public Consultation</u> which aims to define future research priorities in Cloud Computing, Software and Services, ahead of the H2020 ICT Work Programme 2014-15. The draft orientation paper also draws on the reports put forward by NESSI. The consultation is open between 26 February and 2 April and all interested stakeholders including industry, research centres, academia, SMEs and users, are invited to contribute. NESSI encourages all members to participate in the consultation!

In addition to this, NESSI monitors the developments of the European Cyber Security Strategy that was released on 7 February. In this issue, we have also included an announcement from the NESSI project TEFIS which runs testbeds for Future Internet services and has recently released a portal for testbed and Living Lab access and management of Future Internet Experiments.

Public Consultation on Cloud Computing, Software and Services

On 26 February, the European Commission (DG Connect, unit E2 "Software & Services, Cloud") launched a public consultation on Cloud Computing, Software and Services to collect input on how to define future research priorities ahead of the H2020 ICT Work Programme 2014-15.

The consultation is based on a <u>draft orientation paper</u> visualising how the forthcoming ICT Work Programme 2014-15 could address the future research and innovation challenges in the sector. The draft orientation paper draws on the reports put forward by NESSI, as well as the ISTAG report on Software, the Cloud Expert Group publications as well as other documents.

Following the consultation, there will be a workshop organised in Brussels (17 April) to discuss and validate the views expressed by different actors during the consultation. According to DG

Connect, the main focus of the workshop is to bring together existing and new stakeholders, in particular from innovative technological SMEs and from the public sector to better focus the Work Programme so as to maximise its impact on competitiveness and growth.

NESSI participation in the European Data Forum 2013 (9-10 April, Dublin)

NESSI will participate in this high-level conference giving a speech on the topic "A NESSI view on Big Data: a new world of opportunities for software services" which will be based on the Big Data white paper that NESSI recently published.

NESSI project TEFIS launches portal

The TEFIS portal for easy testbed and Living Lab access and management of Future Internet Experiments is now released and addresses researchers or companies in need of support for testing of an idea, prototype or nearly market ready solution for the Future Internet.

TEFIS is a new e-service that gives experimenters easy access to fore-front testbed infrastructures. The portal includes features to plan for and run Future Internet experiments by using services provided by the TEFIS connected testbeds including Living Lab support — all available via one single access-point — individually or in a combination. The services are used today in different experiments in the fields of Mobile media, e-Health, Network performance measurements, e-learning, Collaborative content distribution in mobile networks and SDN.

TEFIS connected testbeds and their services include:

- PlanetLab evaluation of network protocols and networked services over Internet
 PACA Grid computing resources
- ETICS improving the quality and reliability of distributed systems
- Botnia Living Lab end-users <u>involvement</u> in products and services development
 IMS testbed validate and test applications over IMS (IP Multimedia Subsystem)
- Kyatera network performance evaluation

- Registration is free of charge and after logging into the portal you will be able to:

 -___ Use the Experiment Manager to plan your experiment with the services offered by the TEFIS connected testbeds.
- Look for how other experimenters have planned their experiments to know more about how experiments can be structured in practice. European Cyber Security Strategy released

On 7 February, the European Commission adopted its strategy for a cybersecurity alongside a Commission proposed directive on network and information security (NIS). The proposals have been jointly prepared by the Commissioner for the Digital Agenda Neelie Kroes, the Commissioner for Home Affairs Cecilia Malmström and Catherine Ashton, EU High Representative for Foreign Affairs and Security Policy with the aim to prevent and respond to cyber disruptions and attacks.

The EU cyber-security strategy focuses on 5 areas of particular need of attention:

- Achieving cyber resilience
- Drastically reducing cybercrime

- Developing cyber defence policy and capabilities related to the Common Security and Defence Policy (CSDP)
- Developing the industrial and technological resources for cyber-security Establishing a coherent international cyberspace policy for the European Union and promoting core EŬ values

The NIS Directive is a key component of the overall strategy and aims to make sure that Member States, key internet enablers and critical infrastructure operators such as e-commerce platforms and social networks and operators in energy, transport, banking and healthcare services ensure a secure and trustworthy digital environment throughout the EU.

The strategy is currently prepared in the European Parliament where the responsible committee IMCO (Internal Market and Consumer Protection) is still in the process of appointing a rapporteur for the dossier.
